1. Policy Statement

4. Waste Management

4.1 General Waste Control

We will:

- Apply the waste hierarchy: Reduce → Reuse → Recycle → Recover → Dispose
- Plan projects to minimise material waste
- Order materials accurately to avoid excess

4.2 Roofing-Specific Waste

Common waste streams include:

- Broken tiles and slates
- Timber offcuts
- Felt and bitumen materials
- Metal flashings
- Packaging materials
- Insulation materials

We will:

- Segregate recyclable materials where practical
- Use licensed waste carriers only
- Ensure waste transfer notes are retained
- Dispose of hazardous materials via authorised facilities

4.3 Duty of Care

We comply with our Duty of Care obligations and maintain appropriate documentation for waste transfer.

5. Hazardous Materials Management

Where applicable (e.g. older roofing materials):

- Asbestos surveys will be requested prior to works

 - Licensed contractors will be engaged where required
 - Hazardous waste will be handled in accordance with regulations

6. Pollution Prevention

We will take all reasonable steps to prevent pollution including:

- Secure storage of fuels and chemicals
- Spill kits available in vehicles
- Immediate reporting and containment of spills
- Proper control of dust and debris
- Safe storage of sealants and solvents

Storm drains and watercourses will be protected from contamination during works.

7. Energy & Carbon Reduction

Rosbo LTD will aim to:

- Maintain vehicles regularly to ensure fuel efficiency
 - Plan routes efficiently to reduce mileage
 - Encourage responsible driving practices
 - Use energy-efficient tools and equipment where possible
 - Promote sustainable roofing solutions (e.g., improved insulation, skylights enhancing natural light)

8. Sustainable Procurement

Where reasonably practicable, we will:

- Source materials from reputable suppliers
- Use FSC-certified timber where available
- Encourage suppliers with environmental credentials
- Reduce excessive packaging

We expect suppliers and subcontractors to operate in accordance with environmental legislation.
